POWER OFF / VISUAL
The hook shows no deformations, it swivels smoothly, and the safety latch works.

VISUAL / OPERATIONAL
All warning devices work properly and respond immediately.

VISUAL / OPERATIONAL
All crane motions and the emergency stop function agree with control device markings properly and immediately.

VISUAL / OPERATIONAL
All crane mechanisms operate properly and respond immediately without abnormal sound.

VISUAL / OPERATIONAL
All limit switches work normally.

Hoisting brake operates properly.

Konecranes CheckApp for Daily Inspections has been designed to help crane users quickly and easily record their findings when performing pre-shift and/or pre-lift inspections.

It gives you a digitalized and cost-effective way for recording and retrieving daily inspection data that can be used for internal auditing and compliance.

Daily inspections are statutory requirement in several countries.

The daily inspection is a user's – or crane operator's – own assessment of the condition of an asset and environment for safe use. It is not an expert's examination of the condition of an asset or component. Konecranes CheckApp for Daily Inspections follows

the guidance set in the ISO 9927 standard and in applicable statutory regulations.

The app can be downloaded for free on the Apple AppStore and from Google Play for Android devices. Your personnel can use their own or shared company-provided devices to perform the daily inspections.

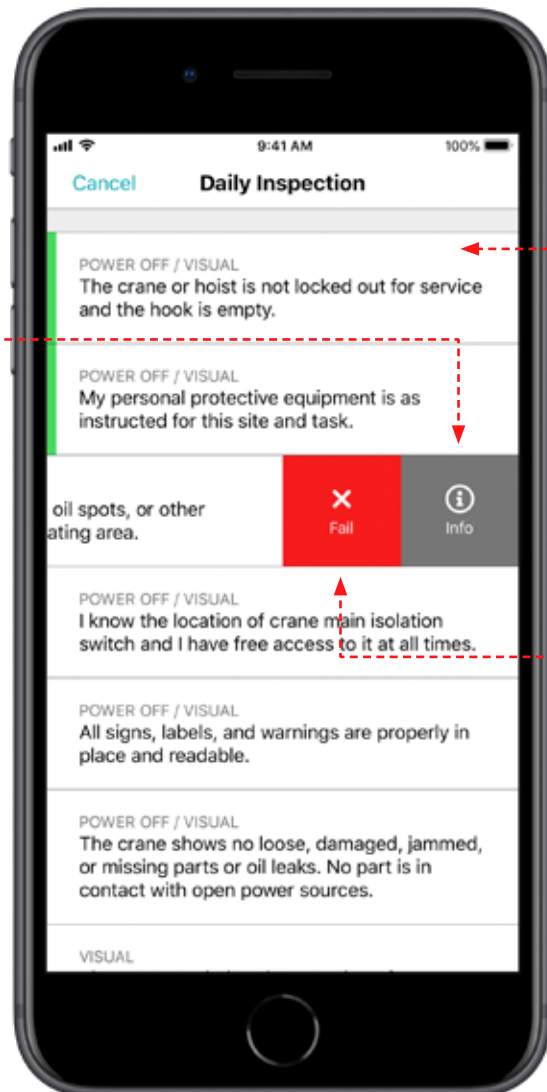

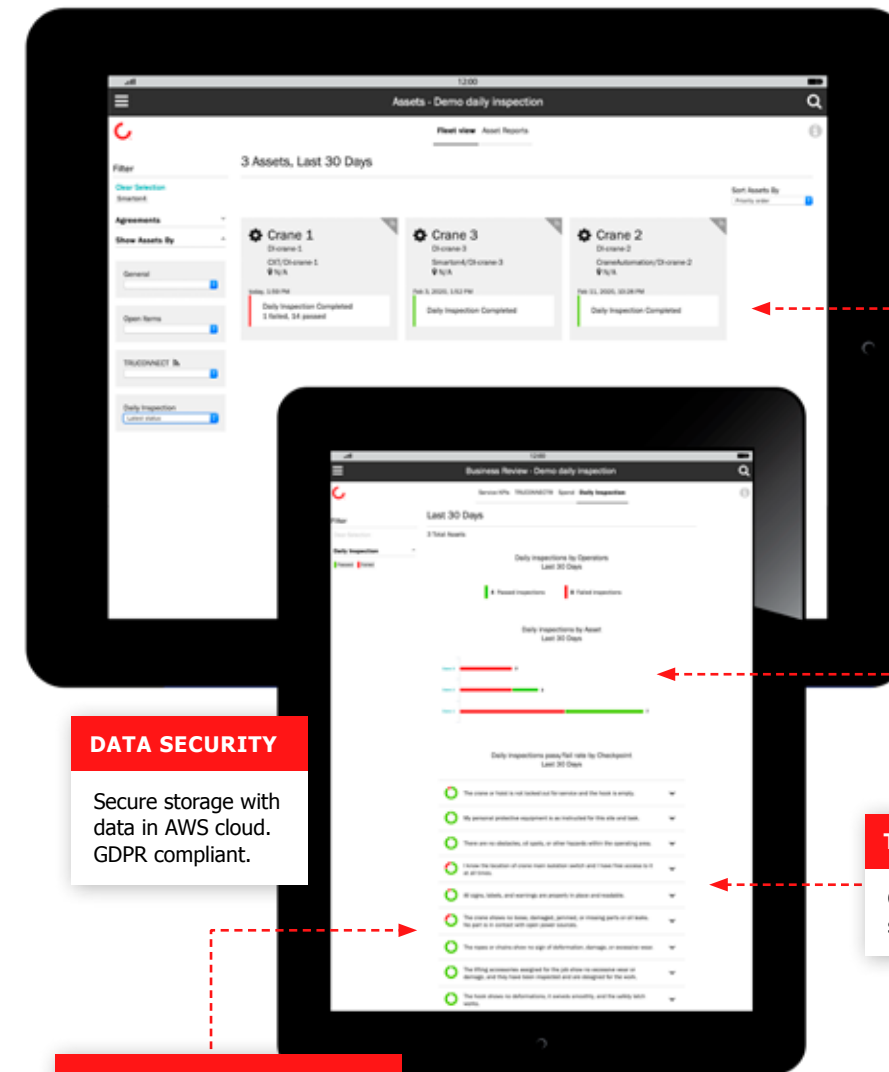

The Daily Inspection view in yourKONECRANES shows daily inspection details as well as useful summary views. Daily inspection details – revealing who performed the inspection, when it was performed, what deficiencies were reported – are accessible through the activity, overview and asset fleet views. A detailed summary for the selected timeframe is provided in the Business Review tab.
